Write the abstract after you have finished your paper, and place it on a separate page after the title page. The formatting of the abstract page is the same as the rest of an APA style paper: double-spaced, Times New Roman 12pt font, one-inch margins, and a running head at the top of the page.

How to Write and Format an APA Abstract | Sample Abstract Page

Abstract. Begin a new page. Your abstract page should already include the page header (described above). On the first line of the abstract page, center and bold the word “Abstract” (no italics, underlining, or quotation marks). Beginning with the next line, write a concise summary of the key points of your research. (Do not indent.)

General Format // Purdue Writing Lab

Begin your abstract on a new page. Place your running head and page number 2 in the top right-hand corner. Center the word "Abstract" at the top of the page. Know your target word count. An abstract should be between 150 and 250 words. Exact word counts vary from journal to journal. If you are writing your paper for a psychology course, your professor may have specific word requirements, so be sure to ask.

Although most regular APA formatting guidelines apply, the abstract page also has specific requirements. The abstract starts with a centered heading "Abstract". In contrast to regular APA headings, no styling is applied. The first line of the paragraph is, unlike regular paragraphs, not indented.
